Upon obtaining an associate's degree in police science, Terry was hired as the youngest police officer in the history of the agency at the age of twenty. During his tenure in the police department, Terry spent more years as a detective than he did in the field as a uniformed officer. Over the years, he developed his investigative skills, not realizing that he would someday own and operate a private investigative agency that has become well known in the legal community.

Terry is a graduate of the FBI National Academy in Quantico, Virginia (171st Session). He also holds a bachelor's degree in the management of human resources which proves to be very helpful when assisting clients dealing with employeerelated issues.

While in the police department, Terry became an assessor for the Commission on Accreditation for Law Enforcement Agencies (CALEA). He received his assessor training in Edmonton, Alberta, Canada and traveled nationwide performing law enforcement agency assessments to determine agency compliance with national accreditation standards.

He was later hired as a consultant with the Tulsa County Sheriff's Office Management Support Unit. While there, Terry assisted in developing agency policy and procedures in compliance with nationally recognized accreditation standards. The agency ultimately became an accredited agency at a national conference in Cincinnati, Ohio.


Terry also volunteered his time as a reserve deputy with the sheriff's office and helped develop the initial courthouse security plan which has evolved over the years but still contains many of the same key components.

Terry went on to conduct background investigations for the Nuclear Regulatory Commission through a government contractor. While doing this, Terry began working as a private investigator with a long-established private investigator in Tulsa. He worked with this investigator for several years, learning the civilian and business side of investigations before breaking out on his own and forming his own agency.

When Cheryl was laid off from her job in 2008 as a quality manager after 20 years with a major industrial distribution company, Terry and Cheryl decided they would join together in business. Since that time, they have built a wellknown and respected private investigative agency.

Cheryl is the office manager for the business. Terry lovingly refers to her as "The Chairwoman." She handles all of the invoicing, file management, taxes, and IT problem solving. In addition, she manages the process service part of the business, maintaining the database, managing deadlines, and coordinating process servers locally, statewide, and across the nation. She also assists with case evaluations, spreadsheets, and timelines.

She has a background in accounting, is very detail oriented, and her background as a quality manager is extremely helpful in analyzing situations in order



to provide innovative and cost-effective solutions for clients.

Terry and Cheryl are active in their local church. Terry is a deacon in the church and teaches a Sunday school class, while Cheryl teaches several Precepts classes. Completion of the crisis hotline training was a requirement for those who were selected to work on the development team. The skills Cheryl developed during that time have been invaluable in many aspects of her life, including personal and business.

## What are your investigative specialties?

Internal theft/fraud, witness interviews/locates, surveillance, civil litigation, insurance fraud/workers comp, and divorce/child custody.

The employee was arrested and charged, and the computers recovered, saving the company untold litigation and expense.

Over the years Terry has assisted municipal and county governments with investigations relating to sexual harassment, internal theft, hostile work environment and EEOC complaints to name a few. If you have employees, you ultimately have problems. Attention to detail is extremely important in such cases. This is where Terry and Cheryl's backgrounds come into play. look. Cameras and recorders have developed to the point that solutions exist for almost any situation. The profession itself has morphed and has become more recognized and legitimate through professional standards, associations, and licensing requirements.

### What has been your most successful marketing tool?

Word of mouth, a significant online presence, and networking.

Over the years, our agency has tried advertising of all sorts. They have not been as fruitful as individual referrals. Clients typically don't want to just check online directories. They want to check with someone they know and trust to point them to the right investigator.

## What advice do you give to prospective PI's?

Be patient! It takes time to establish a successful business. It doesn't happen overnight. Be honest! Learn to manage unrealistic client expectations. Don't let a client talk you into doing something that will end up causing you and/or your client problems later.

Seek advice! Don't be embarrassed to ask questions.

Provide a quality work product and document everything. Expect the unexpected and plan for contingencies. Preparation and planning are key. PI
